**Notification**

The Chairman shall constitute Boards for interview of candidates as a major step towards achieving the objective of citizen centric transparent recruitment for various posts which selection is to be made. More than 2 (two) or Multiple Interview Boards shall be constituted taking into consideration the number of candidates who are eligible to appear for the personal interview to any post.

- I. Ordinarily a single Board shall be constituted if the number of candidates is 5 (five) or lesser than 10 (ten) for selection to a particular post, but where the number of candidates is large, the Chairman may constitute 2 (two) or Multiple Boards for selection purposes.
- II. If the candidates are lesser than 5 (five) no board will be constituted. The Commission will conduct the personal interview as per the transparency procedure.
- III. The Board or Multiple Boards will be headed by a single Member of the Commission who will preside over the interview along with an Expert from the concerned State Government department, and two independent Members who will be appointed by the Chairman.
- IV. If the interview exceeds more than a day (**in cases where two or more Boards have been constituted for the conduct of Personal Interview**), the Members will be rotated on a day to day basis as the Chairman thinks proper.
- V. If a Member appointed by the Chairman is unable to attend the interview fixed for him/her, any other Member may be nominated by the Chairman to hold the interview in his/her place and the fact shall not invalidate the proceedings of such selection.
- VI. If a Member of the Commission who presides over the interview is unable to attend, or has to leave the Board during the course of its sitting and an alternative arrangement cannot be made, the Chairman shall appoint any Member of the Multiple Board to preside over the interview. And the proceedings of the Board shall not be vitiated merely on the grounds that the Member of the Commission is absent.
- VII. The quorum of the members of the Interview Board shall not be lesser than 3 (three).
- VIII. Candidates will not be intimated in advance as to which Board (**in cases where two or more Boards have been constituted for the conduct of Personal Interview**) they will be allotted for their Personal Interview. The Candidates will instead pick lots during registration on the day of the interview to determine by chance the Board that will conduct their Personal Interview.
- IX. **The independent Members shall be appointed by the Chairman from the following persons mentioned below:-**

- (a) He/ She shall be a citizen of India.
- (b) He/ She must not be less than 40 years of age.

And

He/ She must possess the following qualifications which will be prescribed by the Meghalaya Public Service Commission time to time:-

- (i) He/ She must be a well known academician from any reputed and recognized Institutions/Universities in India.
- Or
- (ii) He/ She should belong to any of the All India Services.
- Or
- (iii) He/ She should be a reputed officer working in any Central Government organization.
- Or
- (iv) He/ She should be a reputed officer of the Army, Air force or Navy
- Or
- (v) He/ She should be a sitting Judge or retired Judge as approved by Hon'ble High Court in respect of personal interview of Judicial Officer Grade III.
- Or
- (vi) He/ She should be a distinguished noteworthy personality above others in rank, merit or reputation and who have made a difference to India in the field of Science, Arts, Literature, Industry, Environment, Education, Medicine, Engineering, Law, Music and such other discipline as required for such personal interview.
