Further the Commission having regard to previous experience of system failure and in order to ensure that there is no more problem as far as payment of fees are concerned, directs that fees be paid through means of e-Challan/Cash Payment only at any branch of SBI.

For Cash Payment, please select Payment across Bank Counter. Fill in the required details. An e-Challan will be generated. Take a print out of the e-Challan and make the required payment at any branch of SBI.

After Payment, all candidates are required to upload the e-Challan, signed and sealed by the bank, in the "Upload Documents" link provided in the Recruitment Processing Application (RPA).
