Note: In light of the judgement of Hon'ble High Court of Delhi dtd 13.01.2023 in connection with the WP(C) 3239/2013 as communicated vide Ministry of Education's letter No.20-2/2019-TC (Part) dtd 6th June, 2023, the degrees/certificates of candidates obtained from the Institution of Electronics and Telecommunications Engineers (India) and the Aeronautical Society of India, by taking admission post 31.05.2013, will not be admissible for general post(s) ie. "Graduate in any discipline or technical posts with specific degrees/certificates mentioned in the Note" and advertised by the Commission. Further, the eligibility of the candidates who has obtained degree/certificate from the Institution of Engineers (India), by taking admission post 31.05.2013, will be subject to the decision of the Government in pursuance of the judgement of the Hon'ble High Court of Delhi in the W.P. No 3790/2013.

PARA. 2: Age & Age Relaxation:

For post at Sl.No 1, 2, 3 & 4 :- Age will be calculated with reference to **01.01.2025** and should have attained the age of **18 yrs to 32yrs**. Upper age limit is relaxable by 5 years for SC/ST.

No age bar in respect of regular Government employee who entered Government service within the prescribed age limit.

(a) The date of birth to be accepted by the Commission is as entered in the Matriculation/Secondary School Leaving Certificate/or a Certificate recognized by an Indian University as equivalent to Matriculation or an extract from the official Registers duly Certified by the proper authority of the Board of School Education. Documents other than these will not be accepted by the Commission.

(b) No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporation, Registrar Economics and Statistics and Service Records shall be accepted.

PARA. 4 : SUBMISSION OF APPLICATION

PARA.7. Personal Interview.

Only those candidates who are declared to have passed the Screening Test/ Main Written Examination shall be eligible to the Personal Interview. Ratio to be called for Personal Interview will be as decided by the Meghalaya Public Service Commission from time to time.

***** Only candidates who have produced all the required documents in original relating to their educations qualification, date of birth, caste, community and other certificates wherever required and prescribed by Rules will be deemed qualified to be called for Personal Interview.**

PARA .8. : INSTRUCTIONS

- (1). Applicants are advised to apply well in advance without waiting for the closing date.
- (2). Admission to all stages of the recruitment process for which the candidates are admitted by the Commission will be purely **Provisional** subject to satisfying the prescribed eligibility conditions.
- (3). Applicants are advised to ensure their eligibility with regards to the educational qualification, age and other criteria as required in the post. If an applicant is found not fulfilling any of the eligibility conditions, at any stage of the recruitment process and including the last stage of process of recruitment i.e., "Recommendation", the candidature for the post shall be automatically cancelled by the Commission without notice.
- (4). Applicants are required to indicate in the online application form that he/she belongs to ST/ SC/ OST/OSC or General category but subsequently writes to the Commission to change his/her category, such request shall not be entertained by the Commission.
- (5) **Change of examination centre will not be entertained; therefore candidates are advised to opt their examination centre judiciously.**
- (6). **Sports Person:** Only those who have represented the **State** at the **International, National** and **Regional** level in disciplines listed in the Olympics, is considered a 'Sports Person' as defined under OM No. PER (AR) 150/88/534 Dt. 07/08/2017.
- (7) **PH candidates:** PH stands for Physically Handicapped person. Person defines under OM No. PER (AR) 150/88/534 Dt. 07/08/2017 are considered PH candidate and must possess a Disability certificate issued by competent Authority.
- (8) Candidates must appear for Screening Test/Personal Interview at his/her own expenses.

PARA .9. : COMMISSION'S DECISION ON ELIGIBILITY OF CANDIDATES

While submitting the applications, the candidates have to satisfy that he/she is qualified in accordance with the condition of qualification for the post applied. If he/she is not qualified, his/her candidature shall be summarily rejected/ disqualified at any stage of Interview process (Interview Process includes Screening Test/Written Examination/Personal Interview/ Recommendation). Suppression of any information or giving false information shall invite penal action which may lead to barring from appearing in future recruitment.

Please note that there will be no "**Ineligibility List**". Hence, the candidates are advised to ensure that he/she is qualified to the post advertised in all respect. Irrespective of whether or not candidate is qualified, all will be called for the Screening Test/ Written Examination/ Direct Interview or Personal Interview as the case may be. However, if the candidate is **NOT FOUND QUALIFIED** at any stage of the recruitment process, his/her candidature shall be rejected/cancelled forthwith. PARA.10: DEBARMENT

- (b) Candidates found using unfair/illegal means during the conduct of the recruitment process will be debarred from appearing in examinations conducted by the Commission.
- (c) The Commission is vested with the constitutional duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentially in this process and any attempt by anyone causing or likely to cause breach of this constitutional duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Commission will be sufficient cause for rendering such questionable means as ground for debarment.
- (d) If any candidate is or has been found impersonating or procuring impersonation by any person or resorting to any other irregular or improper means in connection with his/her candidature for selection or obtaining support of candidature by any means, such a candidate may in addition to rendering himself/herself liable to criminal prosecution, will be liable to be debarred permanently from any examination or selection held by the Meghalaya Public Service Commission.
